

2. We require 7000 liters plus or minus 25% during tender period.
3. The requirement of the fuel will be sent to you on quarterly basis and SOS (as and when required)
4. You have to fulfill the requirement within 2 days after issuance of work order.
5. All the quantity or order of fuel need to be supplied with Bowser (Tanker) only.
6. You will be solely responsible for any safety precautions.
7. You will be solely responsible to follow all government guidelines regarding transportation and supply of fuel.
8. Fuel rate will be paid as per the day rate on the date of supply.
9. The service provider/Bidder should have valid Registration/ Incorporation /Shop & establishment Act certificate of firm.
10. The bidder firm should not have been indicted for any criminal, fraudulent or anti-competition activity and not been blacklisted by any Govt. Departments/ESIC/PSU/Govt. Hospital.
11. The bidder/firm must have PAN/TAN/GST Number and bank account with any Nationalized Bank/Scheduled commercial Banks.
12. The acceptance of item will be given only when Item is found as per ordered quantity and up to the satisfaction of inspection officer as well as in-charge. The decision of the competent authority, ESIC Model Hospital Jaipur, shall be final as to the quality of the item and shall be binding upon Supplier. Supply which is found to be of lower quality will be rejected outright and it shall be replaced immediately at the risk and cost of by the supplier.
